- The bidder should be OEM(HPE) or their business partner/service provider/channel partner/ authorised dealer.
- The bidders should have successfully executed the work for Comprehensive AMC for complete Blade Server Infrastructure which includes (SAN Switch/ SAN Storage/ Tape Library/ Data Protector/Core Switch) in any Govt. / Semi Govt./ CPSU/SPSU/ SEB's/ Reputed Private Organization.
- The average annual financial turnover of bidder during the last 03 (three) financial years, ending 31st march of 2022 should be at least 30% of the estimated cost.  
Bidder should have to submit copy of Audited Annual Report (Financial statement) including Profit& Loss Accounts as well as Balance Sheet clearly evidencing the Annual Turnover figure in support of their meeting above stipulated financial criteria. Initial security money will be accepted as Bank Draft/ Bank Guarantee prescribed format not adjustable against running bill. The security deposit shall have to deposit well before execution of the Agreement. Balance **5%** of security money will be deducted from R/A bills. The total Security money may be released after successful completion of every one year after submission of no demand certificate.
8. **Payment Terms:** Payment of Contractor will be made through quarterly running bills which will be verified by Engineer – in – Charge after successful completion of the work.
9. **Paying Authority:** The Accounts Officer, TTPS, Lalpania will be the Paying Authority.
10. **Engineer-in-Charge:** Concerned Electrical Executive Engineer will be the Engineer-in-Charge for this work. The works are to be executed as per direction of Engineer-in-Charge. Anything not mentioned here in shall be decided by the Engineer-in-Charge of the work and shall be binding on the contractor.
11. **Period of Contract:** The period of contract will be valid for one year. If the services rendered have been found satisfactory, period of contract may be extended further as per requirement of site on mutual agreement with same rates and terms & conditions.
12. **Scope of the work:** Scope of the work is attached here as a guideline to execute the work. However, contractor has to execute all the work as per direction of Engineer-in-Charge for proper working of equipments.
13. **Taxes:** All statutory taxes as applicable shall be deducted from each running bill of contractor.
14. **Violation of Terms & Conditions of Tender:** All terms and conditions of tender shall form a part of the contract. If contractor fails to execute the work up to entire satisfaction of Engineer -in –Charge as per terms & conditions of tender, then the contract agreement can be terminated after one-month prior notice and security money shall be forfeited.
15. **Subletting:** The successful bidder will have to execute the work directly on its own. No subletting will be allowed.
16. **Competent Authority:** Managing Director TVNL reserves the right to extend the due date and to reject any/ all the tenders or to increase/ reduce/ distribute the quantity of tender without assigning any reason thereof and not bound to accept the lowest tender or to assign any reason for the rejection of the lowest tender. During the execution of work in case of any dispute between the Engineer-in -Charge and contractor, the decision of General Manager Tenughat TPS will be final and binding.

**17. Facilities to be provided by TVNL:**

- a. Unfurnished accommodation for office with water and electricity inside the power house will be provided free of cost if available.
- b. Guest house facility shall be provided to the visiting engineers/officers of the Contractor on chargeable basis if available.
- c. Unfurnished accommodation may be provided to the employees of the Contractor, if available during the period of execution of work in TTPS Township on rental basis as per departmental rule.
- d. Electricity will be provided on chargeable basis as per JBVNL Tariff.
- e. Medical facility as available at project site shall also be extended to the employee of the contractor. No payment will be made for any medicine purchased from outside or any treatment or test done outside the TTPS Hospital.

**18. Penalty:** The successful bidder has to ensure minimum 95% uptime of all items (mentioned in scope of work) for which he will be required to submit item wise price-breakup before acceptance of the work order. In case, the uptime for particular item falls below 95%, the penalty @4% of the maintenance charges for the particular item shall be levied for every 1% reduction in uptime. In case of any breakdown, fault or emergency maintenance which affects our business, the successful bidder has to attend the same without any delay. In case of failing or deliberated neglect, the work will be carried out through outside agency at the cost & risk of the contractor and this may be liable for termination of their contract.

**19. Departmental Facilities:** In case of major repair of equipments and testing of special equipments contractor should have to provide services of an expert from manufacturer and special tools & tackles. The contractor will also provide all other technical staffs and T&P's consumables etc free of cost. However, all spares' parts shall be provided by TVNL on free of cost.

**20. Agreement:** The firm or his legally authorized representative having Power of Attorney will have to execute agreement with the ordering authority within 30 days of issue of order in the event of placement of order on them.
