 - IV. Hardness testing.
 - V. Ultrasonic Testing machine to check treat to core bond.
 - VI. Metallurgical Microscope.
 - VII. Medium Frequency Induction Melting Furnace.
 - VIII. Continuous Heat Treatment Furnace.

FINANCIAL CRITERIA:-

- I. Average annual turnover of preceding 03 (three) years (i.e. 2016-17, 2017-18 & 2018-19) should not be less than 30% of the estimated cost, certificate by Chartered Accountant/Auditor.
